MIDTERM EXAMINATION SCHEDULE

1. Please check carefully for the correct times and places of your examinations. If you have any questions, check with your teacher. The midterm exam schedule will also be available on our website: www.stpetersboyshs.org.
2. Proctors and students should report to the exam rooms 15 minutes before the exams are scheduled to begin. Proctors, please check students ADMIT cards before distributing exams. Students without admit cards should be sent to the main office immediately.
3. With the exception of Religion, **ALL** school exams are two hours in length. Students **must** remain in the exam room for a minimum of one and one-half hours. (A minimum of one hour for shortened exams.) **Do not collect any exam materials until the minimum time has elapsed.**
4. **MAKE-UP-EXAMS:** Make-up exams will be administered on **Thursday, January 27th and Friday, January 28th at 8:30 A.M.** Those students legitimately absent from a test - **both a telephone call and a note are required** - will be permitted to take make-up exams. A student who cuts an exam will fail for the semester. Students must make-up exams the **FIRST** day they are eligible to return to school if they were absent due to a COVID-related quarantine.
5. For all exams, all students must enter the building through the cafeteria door via the driveway on the right side of the gymnasium.
6. Any student with an exam conflict should see Mr. Walsh **immediately.**
7. Regular winter dress code is in effect during all examinations.
8. The proctoring schedule for make-up exams will be available the week of January 24th.
